Paxton/Petersen moved to approve minutes from May 8, 2017. All ayes. Motion carried. Petersen/Olson moved to approve the Bank Cash Report for May, 2017. All ayes. Motion carried. Hein/Ladegaard moved to approve Claims for June 2017. All ayes. Motion carried.

Committee Reports:

Street - Eckard reported the street sealing and coating was completed. He explained there were some pot holes along the edge that will be filled in the coming weeks.

The City has been asked to put an additional speed limit sign along Terrace Park Blvd so there is one after each of the intersections.

Water – Ballis stated water meters will be read next week for the yearly billing cycle.

Parks & Recreation – Plantings are complete in the parks.

Halbur Lake Service has asked if the city would be interest in replacing the dock at Terrace Park Beach at cost with the donation of steps and for the dock and In / Out service each year starting 2018 summer season. Council agreed to this proposal.

Public Hearing for the amendment to Chapter 92 Water Rates: Mayor Traughber opened the Public Hearing up at 6:34 P.M.; there were no comments from those in attendance or from the public. Traughber closed the meeting.

ADOPT ORDINANCE NO. 118: Motion by Hein, seconded by Petersen to adopt Ordinance No. 118. Roll call vote. All ayes. Motion carried.

Matt Richter present to encourage support of the Historic Arnolds Park, Inc.: Charley Whittenburg discussed the three phases of upgrades to Arnolds Park Amusement Park. He explained a grant was applied for and part of the process was asking the surrounding communities for support. Whittenburg asked Mayor Traughber to sign a resolution stating West Okoboji supports this project. Motion by Paxton/Ladegaard to support Historic Arnolds Park, Inc. on their improvements to the park. Motion carried.

Susie Danbom requesting the use of Danbom Park: Danbom was present on behalf of Brian Rasmussen who is requesting the use of the park for his wedding in July. Rasmussen had sent a detailed letter to the council answering any questions they may have. Mayor Traughber stated use of the park would be granted with the

stipulation that alcohol would not be permitted at Terrace Park Beach. Motion by Ladegaard/Olson to grant use of Danbom Park for the Rasmussen wedding.
