

ORDINANCE NO. 124

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF WEST OKOBOJI, IOWA, BY ADDING NEW LANGUAGE IN SECTION 63.04 “SPECIAL SPEED ZONES” DESIGNATING OKOBOJI BLVD FROM THE INTERSECTION OF TERRACE PARK BLVD TO THE INTERSECTION OF JEPPESEN ROAD TO HAVE A 20 MPH SPEED LIMIT.”

WHEREAS, the Council (“Council”) of the City of West Okoboji, Dickinson County, Iowa (“City”) is considering an amendment to the “Special Speed Zones” ordinance;

WHEREAS, the City is considering adding new language to now require Okoboji Blvd ha a 20 MPH speed limit between the intersections of Terrace Park Blvd and Jeppesen Road;

BE IT ENACTED by the City Council of the City of West Okoboji, Iowa:

Section 1. The Code of Ordinances of the City of West Okoboji, Iowa, Section 63.04 under subsection 1 (Special 20 MPH Speed Zones) and under point A is hereby amended by adding the following:

A. Okoboji Blvd between the intersections of Terrace Park Blvd and Jeppesen Road.

Section 2. REPEALER. All Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed.

Section 3. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any action, provision, or part thereof not adjudged invalid or unconstitutional.

Section 4. WHEN EFFECTIVE. This Ordinance shall be in effect after its final passage, approval and publication as provided by law.
