After the Pledge of Allegiance, Mayor Miner called the meeting to order at 6:33 P.M. Powers/Paxton moved to adopt the agenda. All ayes. Motion carried. Absent: Paxton. Olson/Hein moved to approve the amended consent agenda, which included minutes of the previous meetings 12/12/22, amended claims report for January 2023 and Bank Cash Report for December 2022. All ayes. Motion carried.

# **REPORT OF OFFICERS**

City Administrator Miner reported that he attended the Milford Fireboard meeting and that the city's contribution was lowered by approximately \$3000. Miner also reported that the Dickinson County Board of Supervisors agreed to contribute \$10,000 to the Imagine project at Terrace Park Beach.

Mayor Miner reported that Jim Laadeguard is returning home and he is recovering well.

# NEW BUSINESS

**Resolution 2023-1.** A Resolution Regarding Payment/Contribution to The Lakes Area Hockey Association (LAHA). Scott Bradham was present to discuss the LAHA and how it impacts the community as is relates to tourism. Bradham also informed the council that kids of all ages are able to play and ranges throughout Northwest Iowa and Southwest Minnesota. Paxton/Powers motioned to donate \$500 to the LAHA. All Ayes. Motion carried.

**Resolution 2023-2.** A Resolution Appointing Public Works Director. Olson/Paxton motioned to approve Chad Wellendorf as Public Works Director. All ayes. Motion carried.

**Resolution 2023-3.** A Resolution Setting City Employee Wages Starting January 10, 2023. Councilwoman Powers voiced her concern about the pay increases. Powers cited that most cities in the area have 3-4% raise increases and that the city of West Okoboji wage increases are much higher. Councilman Olson explained that the personnel committee decided on higher wage increases because the salaries being paid to the city employees were much lower than that of surrounding cities. The higher wage increase was to catch city employees up to the salaries being paid to the same positions in other cities in the area. Olson/Sieh motioned to approve Resolution 2023-3. All ayes. Motion carried.

Mike Cedar, Beck Engineering, presentation of the Terrace Park Blvd Project with IMAGINE Iowa. Mayor Miner introduced Larry Arndt with IMAGINE Iowa and thanked all IMAGINE members for attending. Larry Arndt introduced Mike Cedar with Beck Engineering. Cedar began his presentation and showed all residents in attendance the plans for the Terrace Park Beach Project. The council along with IMAGINE Iowa and Mike Cedar answered all the questions/comments/concerns that residents had. One of the biggest concerns was blocking line of view from the 4 houses directly south of the beach. City administrator Miner informed the residents that 26 Ash Trees will be cut down at the beach and only 12 Honey Locus Trees will take their place, which will improve the view. Miner also informed the public that this is the last beautification project that IMAGINE Iowa is going to do in the area. The mayor and council thanked Mike Cedar for his time. No further discussion.

Hein/Sieh moved to adjourn. All ayes. Motion carried. Meeting adjourned at 8:14 P.M.
