## AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF WEST OKOBOJI, IOWA, BY AMENDING PROVISIONS PERTAINING TO WATER RATES.

**BE IT ENACTED** by the City Council of the City of West Okoboji, Iowa:

**SECTION 1. MODIFIED.** Chapter 92, section 02 of the Code of Ordinances of the City of West Okoboji, Iowa, is repealed and the following adopted in lieu thereof:

**92.02 RATES AND SERVICE.** Water service shall be furnished at the following quarterly rates within the City:

**92.04 BILLING FOR WATER SERVICE**. Water service shall be billed and payable in accordance with the following:

2. Bills Issued. The Clerk Shall prepare and issue bills for the water service the month following each quarter.

3. Bills Payable. Bills for combined service accounts shall be due and payable at the office of the Clerk 20 days following the issuance of the billing.

## 92.09 TEMPORARY VACANCY.

.... There Shall be a \$150 fee collected for the installation or removal of a water meter to such property.

92.10 **CUSTOMERS DEPOSITS**. Amy renter or lessee of residential or commercial property is required to post a deposit equal to the current base cost of 90 days for city services to insurance against nonpayment of water usage in excess of the minimum water bill, or any amount owed.

**SECTION 2. REPEALER.** All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

**SECTION 3. SERVERABILITY CLAUSE.** If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

**SECTION 4. WHEN EFFECTIVE.** This ordinance shall be in effect from and after its final passage, approval, and publication as provided by law.
