After the Pledge of Allegiance, Mayor Miner called the meeting to order at 6:31 P.M. Roll call was completed with quorum present. Motion Powers, second Hein adopt the agenda. All ayes. Motion carried. Motion Powers, second Olson to approve consent agenda, which included minutes 5/13/24, Financials for May 2024, claims and claims in vacation for June 2024, Tobacco Permit Okoboji Gas Company, and updated Sign Permit, Variance Conditional Use, Lakeshore Landscaping Permit, and Zoning Permit. Visitors:

Kara Rice with the Arnold's Park Library gave a presentation on services that are available to West Okoboji residents. The library has many services: summer reading program, proctor services, notary, technology services, audio books, DVD and movies, large print readers. 47% of West Okoboji residents use the Arnold's Park library. Shilo Brevik, Chief of Police with Milford Police Department, was not present. Sheryl Thu spoke to the council about her work to dissolve the District 50 Drainage. Mrs. Thu presented council with the history of the Drainage District No.50 This requires a petition from majority of landowners who own at least 60% of the land in the district, a hearing and the district to be free from indebtedness. City of West Okoboji is just a small percent of the land in this district, motion Sieh, second Olson to agree to sign petition for the City of West Okoboji, roll call vote, all ayes, Paxton absent, motion carried.

Tyler Lynn with Beck Engineering with update on Beach Project. With the rain and current work, Steffes is not going to start work on the park until August. Steffes is going to move the fence back so the city can open up the park for utilization until construction starts back up again. The line painter will be coming back and mark the parking lines on the pavers in front of the bathhouse and pergola. Motion Powers, second Hein, to approve Change order #2 to add the parking barriers on the beach side and approve pay authorization #7 for \$91,623.27, all aves, motion carried.

Ms. Kostinec brought up about having a recycle can by the tin can so people can sort out those refundable cans. There is a gentleman in the community that sorts them out and then uses the money he received to purchase food for the food banks in the area. Council agreed to go ahead and set a container.
